This Privacy Policy describes the information Claxton Cozart Creative Group, LLC collects when you sign up for, use, access or otherwise interact with any Claxton Cozart Creative Group, LLC applications, products, services, or websites (collectively, "Services"), how we use and share that information, and the choices we offer. This policy applies to all information we collect through our Services, even if you have not signed up for a Claxton Cozart Creative Group, LLC account or downloaded one of our applications. This policy does not, however, describe the practices of third parties that may collect information from you when you interact with them, including third parties that we use to accept payment for goods or services. We encourage you to ask them about their privacy practices before providing any information to them.

We may change this policy from time to time. If we make changes, we will notify you by posting the updated policy and revising the "Last Updated" date above. We encourage you to review the policy whenever you use our Services to stay informed about our information practices and about the choices available to you.

### Collection of Information

#### Information You Provide

We collect information you provide, such as when you sign up for a Claxton Cozart Creative Group, LLC account, when you provide information as part of our identity verification process, or in the course of completing a form or a transaction. We may collect, but are not limited to collecting, the following: basic user information, such as your name, email address, mailing address, phone number, images, and documents; and other historical, contact, and demographic information.

We also collect information when you upload or send information to or through the Services about your products and services (including inventory, pricing and other data), participate in contests or promotions offered by Claxton Cozart Creative Group, LLC or our partners, respond to our surveys, or otherwise communicate with us.

### Information We Collect from Your Use of the Services

We collect information about you when you use our Services, including as follows:

- **Request Information.** When you use our Services to request changes to or create mobile marketing tools, to request changes to or create internet marketing tools, to request changes to or create reputation marketing tools, to create or make changes to video marketing tools, we collect information about when request occurred, a description of the request, and information about the devices used to complete the request.

- **Location Information.** When one of our applications is open on your mobile device, we periodically receive information about the location of the device. For more information and to learn how to disable location information, please see "Your Choices" below.

- **Device Information.** We collect device-specific information when you access our Services, including your hardware model, operating system and version, unique device identifiers, mobile network information, and information about the device's interaction with our Services.

- **Use Information.** We may collect information about how you use our Services, including your access times, browser types and language, and Internet Protocol ("IP") addresses.

- **Information Collected by Cookies.** We may use various technologies to collect information, and this may include sending cookies to your computer or mobile device. Cookies are small data files that are stored on your hard drive or in device memory by a website. Among other things, cookies support the integrity of our registration process, retain your preferences and account settings, and help evaluate and compile aggregated statistics about user activity.

## Information We Collect From Other Sources

We may also collect information about you from third parties, including but not limited to third-party verification services

## Third-Party Advertisements and Analytics

We may allow third parties to serve advertisements in connection with our Services and to provide analytics services. These third parties may use cookies, web beacons, and other technologies to collect information, such as your IP addresses, identifiers associated with your mobile device or applications on the device, the browsers you use to visit our Services, pages viewed, time spent on pages, links clicked, and conversion information. This information may be used by Claxton Cozart Creative Group, LLC and other companies to analyze and track data, determine the popularity of certain content, deliver advertising and content targeted to your interests, and better understand your usage. This policy does not apply to, and we are not responsible for, third-party cookies, web beacons, or other tracking technologies, and we encourage you to check the privacy policies of these third parties to learn more about their privacy practices. ## Use of Information

We use information about you to provide, maintain, and improve our Services and to deliver the information and support your request, including technical notices, security alerts, and support and administrative messages.

We may also use information about you to improve and personalize the Services. To take just one example, when you sign up for a Claxton Cozart Creative Group, LLC account, we may associate certain information with your new account, such as information about other accounts you have or had with Claxton Cozart Creative Group, LLC and prior products and services you used through the Claxton Cozart Creative Group, LLC Services.

We may use information we collect to send you news and information about our Services and to communicate with you about products, services, contests, promotions, incentives, and rewards offered by us and select partners.

We may also use information about you to track and analyze trends and usage in connection with our Services; to process and deliver contest and promotion entries and rewards; to protect our rights or property; to verify your identity; to investigate and prevent fraud or other illegal activities; and for any other purpose disclosed to you in connection with our Services.

We may, or we may not use third-party service providers to, process and store personal information in the United States and other countries.

#### Sharing of Information

We may share personal information about you as follows:

- In connection with, or during the negotiation of, any merger, sale of company assets, financing, acquisition, divestiture, or dissolution of all or a portion of our business;
- If we believe that disclosure is reasonably necessary to comply with any applicable law, regulation, legal process, or governmental request; to enforce applicable agreements or policies; to protect the security or integrity of our Services; and to protect us, our end users, or the public from harm or illegal activities; and
- With your consent.

We may also share aggregated, non-personally identifiable information with third parties.

#### Children

This site does not knowingly collect or solicit Personally Identifiable Information from or about children under 13 except as permitted by law. If we discover we have received any information from a child under 13 in violation of this policy, we will delete that

information immediately. If you believe This Site has any information from or about anyone under 13, please contact us at the address listed below.

## Security

We take reasonable measures, including administrative, technical, and physical safeguards, to help protect personal information from loss, theft, misuse, and unauthorized access, disclosure, alteration, and destruction.

## Your Choices

### Location Information

When you first launch our mobile applications, you will be asked to consent to the application's collection of location information. We do not require this location information in order to provide our Services, but you may not be able to use all of our Services if you do not consent to this information. If you initially consent to our collection of location information, you can subsequently stop our collection of location information at any time by changing the preferences on your mobile device. You may also stop our collection of location information by following the standard uninstall process to remove Claxton Cozart Creative Group, LLC applications from your device.

## Cookies

Most web browsers are set to accept cookies by default. If you prefer, you can usually choose to set your browser to remove or reject cookies; however, our Services may not function properly if you do so.
